## Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

## What is this product?

### Type

This product is a sub-fund of SEB SICAV 2, a Luxembourg open-ended investment company with variable share capital (SICAV) with multiple sub-funds, which qualifies as a UCITS.

### Term

The fund has no maturity date. The management company has the right to terminate the fund, more information can be found in the fund's prospectus.

### Objectives

**Investment objective** The fund aims to increase the value of your investment over time.

**Investment policy** The fund is actively managed and invests primarily in stocks in listed private equity companies, globally. The fund invests in a limited number of companies, normally between 30 and 45.

Investment decisions are based on selection and analysis to identify listed private equity companies and portfolios, as well as listed companies where private equity companies are minority owners. The return is determined by how much the fund's holdings increase or decrease in value during your holding period.

The fund promotes sustainability characteristics and is therefore classified as Article 8 according to the EU Sustainable Finance Disclosure Regulation (SFDR). The fund follows the management

company's sustainability policy, which is available at [www.sebgroup.lu/funds](http://www.sebgroup.lu/funds).

**Benchmark** Although the fund does not have a benchmark, it uses a fixed percentage of 6% per annum to calculate performance-based fees.

**Subscription and Redemption** You can normally buy and sell units in the fund every Luxembourg bank business day, except December 24 and 31.

**Distribution Policy** The unit class is non-distributing.

### Intended retail investor

This fund may be suitable for you who intend to keep your investment for at least 5 year(s), and who understands that the money invested in the fund can both increase and decrease in value. It is therefore not certain that you will get back all the invested capital. In order to invest in the fund, it is not required that you have any special prior knowledge or experience of mutual funds or financial markets.

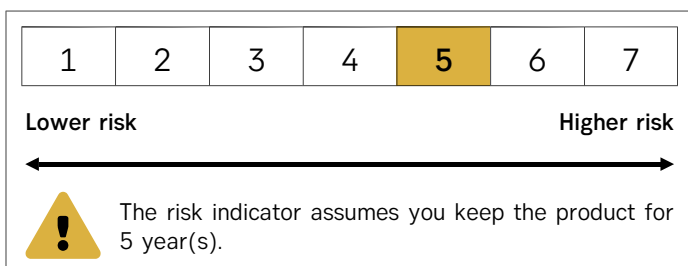

## What are the risks and what could I get in return?

### Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

We have classified this product as 5 out of 7, which is a medium-high risk class. This means that the fund has a medium-high risk of increases and decreases in the share value. The indicator primarily reflects the increases and decreases of the asset classes in which the fund has invested.

**Be aware of currency risk if you invest in a share class denominated in a currency that is different from the official**

**currency of the country where the share class is being marketed. You will then receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.**

This product does not include any protection from future market performance so you could lose some or all of your investment.

### Performance scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

**The unfavourable, moderate, and favourable scenarios shown are illustrations using the worst, average, and best performance of the product or a suitable benchmark over the last 10 year(s). Markets could develop very differently in the future.**

The stress scenario shows what you might get back in extreme market circumstances.

**Unfavourable:** this type of scenario occurred for an investment in the product or a suitable benchmark between 31 March 2015 and 31 March 2020.

**Moderate:** this type of scenario occurred for an investment in the product or a suitable benchmark between 30 January 2015 and 31 January 2020.

**Favourable:** this type of scenario occurred for an investment in the product or a suitable benchmark between 31 October 2016 and 29 October 2021.

## What happens if SEB Investment Management AB is unable to pay out?

According to law, the fund's assets may not be stored by the management company. Instead, each fund must have a specific depository that takes care of the safekeeping of the fund's assets. In the unlikely event that the management company goes bankrupt, the management of the fund is taken over by the depository. There is no arranged compensation or guarantee scheme for investors in the fund.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment. If the fund is included as part of another product, e.g. unit linked insurance, there may be other costs for that product.

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the product's recommended holding period we have assumed the product performs as shown in the moderate scenario.
- 10,000 EUR is invested.

(\*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 9.7% before costs and 7.2% after costs. We may share part of the costs with the person selling you the product to cover the services they provide to you. They will inform you of the amount.

### How long should I hold it and can I take money out early?

**Recommended holding period: 5 year(s)**

The fund has no requirement for a minimum holding period, but since it invests in equities, it is suitable for a medium to long-term investment horizon. You should be prepared to hold your investment in the fund for at least 5 year(s). You normally have the opportunity to sell your fund units every bank business day in Luxembourg except December 24 and 31 without any extra fee.
